6.1 To approve the accounts to be paid

The Council approved the accounts as per the payment list for August 2023

6. To discuss and agree to move The Council CCTV system from the Library to the Fire Station and agree any further expenditure.

The Council agreed to move the CCTV system from the library to the fire station and agreed the extra annual cost of £561.50

7. To consider the proposal from Robert Hitchins regarding the regeneration and adoption of the play area at Blenheim Drive Newent.

The council by unanimous decision agreed to explore options available regarding Adopting the Play area and carryout a consultation with local residents

8. Allotments

8.1 to approve allotment fees for the season 1st November 2024 – 31st October 2025

The Council by unanimous decision approved the revised allotment fees and early payment discounts for the season 1st November 2024 to 31st October 2025.

- £57 per full plot (an increase of £3 on 2023/2024 fee)
- £29 per half plot (an increase of £2 on 2023/2024 fee)
- £15 per quarter plot (an increase of £1 on 2023/2024 fee)
