### **Public Participation Session**

#### Public Member 1

A member of the Public commented that they were disappointed with Item 49.7.3 from the meeting held on Monday 27<sup>th</sup> September.

He felt the item was not discussed sufficiently regarding Flood Planning. He has asked if the item can be added to the next Council Meeting agenda and for groups to be notified of any updates, especially around the Watery Lane flood issues.

The Mayor responded by stating that the Council will correspond directly with him.

#### District Councillor Vesma

District Councillor Vilnis Vesma, District Councillor for Newent and Taynton Ward, commented on the Active Travel Infrastructure Task Group meeting held on 5<sup>th</sup> October 2021, which he attended on behalf of Newent Town Council. Cllr Vesma explained that the Task Group comprised representatives from the Forest of Dean District Council, town and parish councils, Gloucestershire County Council (as the highways authority) and other stakeholders.

A senior transport planner from GCC had attended the meeting and the following salient points emerged: .

- I. "Active Travel" (usually meaning cycling and walking) is most relevant in urban contexts. In rural areas however it can be part of a strategy encompassing public and shared transport.
- II. The County's emphasis is on links to Gloucester. Routes from Highnam and Maisemore were definite priorities. Newent's position was uncertain but Cllr Vesma had argued that electric bikes made a Newent-to-Gloucester corridor feasible.
- III. The Newent-Gloucester route being promoted by Newent Cycling Group passes Hartpury College and University (also represented on the Task Group) and would give their staff and students an active travel link to Newent as well as Gloucester.
