- A. P0887/22/TCA 41 Church Street Newent
Reduce height of Palm tree (*Trachycarpus fortuneii*) to 1.8 metres, due to proximity to summer house, boundary fence and overhead power cable.

- B. P0872/22/AG Reciprocal Roof Roundhouse At Woodland Site In May Hill

Erection of a single storey rear extension with associated works

Erection of a three storey side extension with rear balcony, two storey side extension, single storey front, side and rear extensions. Erection of front porch and covered side access. Construction of subterranean basement. Construction of rear dormer extension and patio terrace and landscaped hardstanding to front and associated works. Demolition of existing garage, lean-to sheds and conservatory.

APPEAL DECISION

APP/P1615/w/21/3275360 The Willows, Horsefair Lane, Newent, GL18 1RG
The appeal is made against the decision of Forest of Dean District Council. The application ref P0542/21/OUT dated 16 March 2021 was refused by notice dated 12 May 2021. The development proposed is the erection of one dwelling (associated works to include a vehicular access).
