APPLICATIONS

A. P1368/22/FUL Newent Recreation Ground, Watery Lane, Newent Erection of new community building. Removal of temporary cafeteria building and shipping containers. (For information only)

The clerk commented that any responses to the application will be held in the Planning Portal of the Forest of Dean District Council.

B. P1098/22/FUL 2 The Stables, Southend Lane, Newent, Gloucestershire Erection of two dwellings with associated parking and work.

The Committee resolved by a unanimous decision to 'Object' to this application, on the following grounds:

- a) Foul sewage: will not be discharged into the main sewer.
- b) Septic tank: reassurance is needed that the septic tank will be able to cope with the overflow of waste, as the council is aware of overflows previously from the septic tank.
- c) Rain Water Damage: the ability to drain is constrained and the council can see no evidence that this has been addressed, at this stage.
- d) Neighbour Notifications: it has been identified that at least eight neighbouring properties that should have been notified were left off the notification list regarding the planning application. Notification should have been provided to properties opposite and down Southend Lane, Newent.

C. P0891/22/FUL 17 The Scarr Newent Gloucestershire GL18 1DQ Erection of a two storey rear extension with associated works.

The Committee resolved by a unanimous decision to 'No Objection' to this application, subject to the Conservation Officers reports.

D. P1388/22/FUL Old Malt House , High Street, Newent, Gloucestershire Erection of single storey rear extension and glazed veranda to rear and erection of a small lean-to store. Demolition of existing conservatory.

The Committee resolved by a unanimous decision to 'No Objection' to this application.

E. P1405/22/FUL Land Rear Of, 35 Court Lane, Newent, Gloucestershire Erection of 2 No. dwellings with car parking, landscaping and associated works
