12.2 Recreation ground surfaces

12.3 Rodent problem at the old council yard Horsefair lane

Our waste management company have reported an issue with rats around the bins in the old council yard which is a health and safety hazard to their operatives who are reluctant now to empty our bins. This causes issues with emptying our bins in the amenity areas. The old council yard is not owned by Newent Town Council it belongs to GCC. I have investigated prices for some pest control on the site to reduce the problem. The cost of this is £80.00 Per calendar month.

As this is not our site and there is a limited pest control budget intended for mole control in all areas I propose we take the money from budget heading 300-4605 pest control, for the duration of only a 2 month period to control the existing population of rats.

Recommendation

To agree the expenditure of £80 Per calendar month for pest control at the old council yard for 2 months. From budget heading 300-4605.
