Newent Town Council fully supports the creation of this SPD and notes with interest the innovatory Farmscoper tool.

We are not aware of any phosphate run-off into watercourses within this parish, but are pleased to learn of this initiative for the benefit of the wider FoDDC district including the River Wye, and should more local run-off occur in future".

P1683/22/TPO Mount Pleasant, Culver Street, Newent, Gloucestershire Undertake the following works to Horse Chestnut T7 of DFTPO 100: Reduce crown by approximately 3 metres overall, due to crown dieback. Remove lowest branch overhanging road, and reduce the two lowest branches overhanging footway in line with the hand rail, to balance the tree, and to improve public safety.
