Trees covered by G41 TPO 54 \(as indicated on the submitted sketch plan\). A mixture of species including, Oak, Ash, Sycamore, Alder, Thuja, Holly, and Birch. Crown lift trees to approximately 3 metres from ground level, to allow better access for grass cutting, and to allow members of the public to walk unhindered around the park area.
