## Councillor Vacancy to be filled by Election

As announced in the last newsletter, following the resignation of Cllr June Davies, there is a vacancy on our Town Council of thirteen members.



Written notice has now been received by FoDDC from ten petitioners which calls for an election rather than a co

-option. However, under the present emergency, no elections can be held until May 2021.

Thinking of standing? Come along to our twice monthly meetings (currently on Zoom) and find out what we do. You can now speak to the council on any matter at the start of the meeting, not just on items on the agenda as previously.

## Planning Matters

Planning certainly does matter. We want to hear from both residents and applicants when we discuss how to respond to planning applications. As a statutory consultee, the Town Council is invited to give its approval or objections to all planning applications in our parish before they go to the District for final decision. We want developers both large and small to come and talk to us at an early stage. Local residents can speak or write to us about small or larger plans but if we don't know your views on the material planning matters, it is difficult to represent you and to make the best considered decisions.



However, if the government's new proposals go ahead, there will be little say at local level apart from the broad decisions as to which of the three new zones all land will be allocated. These are Growth, Renewal or Protection. The Town Council will be making a response to this white paper and individual responses are also welcome. The deadline is 29th October. These proposals, if implemented, would overturn the present system which is open to the local community to have its say on all developments and applications.
